Improving CWA-NPDES Permit Compliance at Small Wastewater Treatment Systems

This webinar series supports the joint EPA and Authorized State Significant Noncompliance (SNC) Rate Reduction National Compliance Initiative (NCI), which is aimed at improving surface water quality and reducing potential impacts on drinking water by assuring that all Clean Water Act (CWA) – National Pollutant Discharge Elimination System (NPDES) permittees are complying with their wastewater discharge permits. The most common dischargers in significant noncompliance are wastewater treatment systems discharging less than one million gallons per day.
